Now these tests are all done over WIFI and according Zito they will not accept those speeds. My question there is most everything in todays households runs on WIFI from your phone all the way up to major appliances. My security system, door bell, streaming service, daughters ipad, gaming systems, phones, washer and dryer all use WIFI. Without good signal these items do not function properly or at all. I've been told by every technicisan that comes to my house to diagnose the problem that this is the best service i will ever get. Now we can get to how many times a day the internet goes down. Every day the internet goes down at least 2 times. Today the internet is not just down at my house but the entire city of Liberal since 5am. When i call to speak with Zito they are not even located in Kansas. Their offices are out of PA. This morning I am told that the reason it is down is due to the fact that they use COX cable inffrastructure and the problem is on their side not Zito. the lady could not give me an ETA as to when it would be up. First, we want to voice our support for Epic Touch and the work they have done in rural Southwest Kansas. Access to quality internet is not ubiquitous in this region, and supporting a locally owned company that genuinely cares about the region it serves should be first and foremost for any Department of Commerce project. So many small businesses in Liberal are unable to utilize the common amenities that others throughout the country use--a POS system, wifi for customers, a loyalty program app, etc.--because they simply do not have adequate broadband service. This grant would allow Epic Touch to open a new corridor of businesses with those resources in Liberal. As a community development support organization, it would be amazing if we could offer these services to perspective businesses.

Second, we want to encourage the Department of Commerce to be judicious with their funds. When the CERG grants were made available, Epic Touch chose not to apply because the company recognized that projects of this magnitude would compromise quality under such tight time constraints. The work Epic Touch has done is always personal, methodical, and reliable. They cut no corners.
