Authorized Forms of Documentation

State of Kansas Description of Examples of Documentary Evidence:

QUESTION 12 – Verification of Age (must be provided for SNAP and RRC target groups)

- Birth Certificate
- Valid Driver's License
- Permanent Resident Card
- Passport
- Valid Federal/State Gov't I.D.
- Social Security Number Verification System (SSNVS)

QUESTION 13 – Veteran Documentation

- APPLICATIONS SUBMITTED (POSTMARKED) ON OR BEFORE 04/22/2021
 - National Personnel Records Center (NPRC)
 - Servicemembers Civil Relief Act (SCRA)
- APPLICATIONS SUBMITTED (POSTMARKED) ON OR AFTER 04/23/2021
 - DD-214 showing honorable discharge.
- **Service-Connected Disability** Letter of Separation or other agency documents issued only by the Department of Veterans Affairs (DVA) on DVA Letterhead certifying the Veteran has a service-connected disability and signed by the individual who verified this information.

QUESTIONS 14 & 16 - TANF and SNAP

 TANF/SNAP (Cash Assistance &/or Food Stamp) Benefit History with Case Number Identifier signed by an authorized individual on state letterhead with a specific description of the months and year that benefits were received dating back to 08/1997 for all states in which benefits were received.

QUESTION 15 – Vocational Rehabilitation and/or Ticket to Work (see question 13 for Veteran Affairs)

- Vocational Rehabilitation Agency letter signed by an authorized individual on agency letterhead
 that the individual listed on the IRS Form 8850 has or had a written plan for employment (IPE)
 AND has or had an IWRP showing the date opened and the date closed.
- Ticket to Work will be verified by the SWA but **MUST** attach the signed first page of the IRS Form 8850.

QUESTION 17 – Ex-Felon

- KASPER only if documentation shows the required information as listed on the Ex-Felon target group criteria. Sentencing Date as listed on the Kansas Department of Corrections – KASPER search is different from the actual required conviction date.
- Parole Officer's Statement signed by an authorized individual on agency letterhead that the individual listed on the IRS Form 8850 showing the date of felony conviction, participation in a work release program, placement in a Residential Re-Entry Facility and/or release from prison.
- Correction Institution Records
- Court Records

QUESTION 18 & 19 – Designated Community Resident/Rural Renewal County (RRC)

- Proof of address <u>MUST</u> match the address listed on the first page of the IRS Form 8850.
 - o W-4
 - Valid Driver's License
 - o Residential Lease Agreement with the individual's name that is on the IRS Form 8850
 - Utility Bill
 - Voter Registration Card
 - Government Issued Award or Tax Statements
 - o ArcGIS
 - Nexus/Lexus and Innovative are NOT an authorized form of documentation.
- Proof of Age (please see question 12 above)
- Empowerment Zone or Summer Youth (This target group is not authorized in Kansas)
- Proof of County
 - o (see page 4 of the ICF ETA 9061 for instructions on how to obtain this from USPS.com)

QUESTION 20 - Supplemental Security Income (SSI)

• Supplemental Security Income will be verified by the SWA but **MUST** attach the signed first page of the IRS Form 8850.

QUESTIONS 21 & 22 – Unemployed Veteran (must have documentation of veteran status see question 13)

- Unemployment Insurance (UI) Claims Records showing weekly payments for all states in which UI benefits were received.
- UI Wage Records showing quarterly wages for all states in which employee has worked in the year prior to hire date.

QUESTION 23 – Long-term Unemployment Recipient

- Unemployment Insurance (UI) Claims Records showing weekly payments for all states in which UI benefits were received.
- UI Wage Records showing quarterly wages for all states in which employee has worked in the 27-week period prior to start date.
